

PRIVACY POLICY

This charter (the “Charter”) formalizes our commitment to respecting the personal data of Internet users browsing the internet site: <http://www.revstil.com/> (hereinafter referred to as registered office is the “Site”) which is operated by the Belgian company SILVERT STONES CONSULTING SPRL register with the BCE under number BE0883.296.549 and whose registered office is located at Avenue Molière, 145, Boîte 15, 1190 Forest (hereinafter referred to as “SILVERT STONES” or “We”).

1. GENERAL PRINCIPLES

All personal data (hereinafter referred to as the “Personal Data”) collected by us will be processed in accordance with Belgian and European regulations applicable to the protection of Personal Data, in particular Directive 2002/58/CE, as amended by Directive 2009/136/CE transposed into Belgian law via the specific rules for sending commercial communications as set out by Book VII of the Code of Economic Law. You are invited to read this Charter carefully and to take note of its content.

2. RESPONSIBILITY FOR PROCESSING PERSONAL DATA

SILVERT STONES takes responsibility for processing Personal Data and provides a service in gemmology, the creation of /and manufacturing of bespoke fine and fine jewellery as well as the sale of manufactured jewellery items and precious stones, gemstones, diamonds or pearls.

3. SCOPE OF APPLICATION

The Site is only intended to present the activities of SILVERT STONES, but no transaction can be carried out on it. If you wish to use our services, please contact us by email or by phone via the contact details mentioned on the Site. Only in this case will We process your Personal Data.

This Charter describes what Personal Data We may process, for what purposes, in what context as well as your rights in accordance with the relevant regulations.

4. PERSONAL DATA THAT MAY BE COLLECTED

a. Direct collection of Personal Data when sending an email or telephone contact:

When you contact us directly via email or by phone to ask about the services provided by SILVERT STONES or to contact us, the following Personal Data may be processed:

For a physical person:

- Names
- Forenames
- Civility
- Civil Status

- Date and Place of Birth
- Email address
- Landline telephone number and/or mobile phone number
- Home address
- VAT Number/ BCE Registration Number

For a company

- The name of the company
- The address of the registered office
- Name of the representative
- Forenames of the representative
- Email address
- Landline telephone number and/or mobile phone number
- VAT Number/ BCE Registration Number

b. Navigation on the Site: Information collected by means of technological means

Connection Data

When you use the Site, our computer systems may collect passive data such as your IP (Internet Protocol), the MAC address of your computer, the date and time of the connection, as well as the type of browser, etc.

Navigation Data

We also use Cookies to collect information to track how you access the Site, the pages you visited and how long you spend on each page.

5. PURPOSE OF DATA PROCESSING

- a. The Personal Data We collect directly and/or indirectly is used primarily to answer your questions concerning our services, if any, to contact SILVERT STONES directly.

6. DISCLOSURE OF DATA

- a. We may disclose your Personal Data, if necessary, in order to a/ comply with applicable laws or satisfy a court order or an injunction; or b/ to protect and defend our rights or the users of the Site.
- b. Your Personal Data may be processed by third party partners, suppliers, and subcontractors, where necessary. We will ensure that these third parties comply with our privacy and Personal Data protection and are bound by the same obligations to which we are subject in relation to the protection of your Personal Data.

7. RIGHT OF ACCESS, MODIFICATION, RECTIFICATION AND DELETION

- a. You have the right to access, modify, rectify, and delete your Personal Data. This right can be exercised by sending an email to: info@revstil.com.
- b. Before responding to a request to amend, correct or delete your Personal Data, We may ask you to identify yourself.

8. SECURITY

SILVERT STONES undertakes to use its best efforts to protect your Personal Data to prevent your Personal Data from being distorted, damaged, or otherwise comprised or communicated to non-authorized third parties.

9. DATA RETENTION

- a. SILVERT STONES will only keep your Personal Data 1 year after your contact request or 3 years after you have made use of our services.

10. RIGHT OF PORTABILITY

- a. You also have the right to receive the Personal Data which concern you and which you have provided to SILVERT STONES in a commonly used, machine readable structured format and the right to transfer them to another controller when the processing of these Personal Data is based on consent, or a contract carried out using automatic processes.

11. RIGHT OF COMPLAINT

- a. Without prejudice to any administrative or jurisdictional remedy, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State of your habitual residence, place of work or place of alleged violation if you consider that the processing of your Personal Data violates the GDPR.
